



Request for Special Consideration on 9 September 2022

Since Her Majesty Queen Elizabeth passed away yesterday, the UK Government declared 10 days of official mourning, during which most respectable organisations either cancelled or postponed their events and put aside disputes.

LinkedIn and its owner Microsoft are both respectable organisations. The lawyers, journalists and social media experts helping our high profile case ask LinkedIn and its owner Microsoft to either cancel or postpone the termination of our LinkedIn account scheduled for Tuesday 13 September as a mark of respect to 68 million people in the United Kingdom.

Supporting evidence:

All of our volunteers and majority of our 84,000 followers on 6 social media platforms (including the ones on LinkedIn) are loyal supporters of Her Majesty Queen Elizabeth, some of us have worked for or met her in the past. As you can understand, we are deeply shocked and are mourning her death with the rest of the world.

Under the circumstances, we respectfully ask LinkedIn and its owner Microsoft to either postpone or cancel the termination on grounds of compassion, since compassion is the foundation and fabric of our society.

What happens if you decide to terminate on Tuesday 13 September

This will leave us with no choice but to file an Emergency Judicial Review and an Urgent Injunction in the High Court.

As your legal department will inform you, we are exempt from the pre-action process in an Emergency Judicial Review and an Urgent Injunction in the High Court. This means you will get a Court Order making it unlawful and illegal for you to terminate our account without any further communication from us.

Communication:

For the reasons outlined on page 1 of this letter and in previous letters, we are currently too upset to read any lengthy replies.

This is how we would like you to respond by the end of today or as soon as possible:

In the subject box of an email to 1 of the 2 email addresses we registered with LinkedIn or in a direct message to our Twitter profile (https://twitter.com/compassion_heal) , type the number 1, if you agree to cancel the termination of our LinkedIn account on 13 September on the basis of all the evidence we sent in the last month and to avoid complex legal actions that will last decades. As you will see in the evidence bundles we sent, we have invested immeasurable and incalculable energy, time and resources in our LinkedIn account spanning many years (evidenced by the 26,000 followers we attracted) and if you are in our shoes, you will definitely want justice.

In the subject box of an email to 1 of the 2 email addresses we registered with LinkedIn or in a direct message to our Twitter profile (https://twitter.com/compassion_heal) , type the number 2, if you agree to postpone the termination of our LinkedIn from 13 September until your legal department have fully analysed all the evidence we sent in the past month or until the conclusion of our forthcoming legal actions (if you decide to go ahead with inflicting detriments on us).

Whichever option you select, leave the main body of email blank as we are currently too upset to read words from you.

Purpose of this letter from loyal customers based on independent legal advice:

We have been loyal customers of LinkedIn for many years and our LinkedIn account entitled "Healed by Compassion" has nearly 26,000 followers (among top 5% of LinkedIn accounts, according to IT and Social Media Experts).

This is an appeal against the mistake of ongoing restrictions on our LinkedIn account by denying access and making our LinkedIn profile completely invisible to 7 billion people around the world on the internet since 29 July 2022

Acknowledgement of support from LinkedIn and Microsoft:

We have a combined total of approximately 84,000 followers across all major social media platforms and thousands of our followers are friends or former colleagues who work in social media or IT giants, including LinkedIn and its owner Microsoft.

We would like to thank our friends and former colleagues at LinkedIn and its owner Microsoft for their professional support and expert advice in the issues raised in this letter.

Why the ongoing sanctions were wrongly applied:

We are a well respected international support network, founded in 2010. One of our functions is to support victims.

Some of the perpetrators and their supporters who wronged the many victims we support have devoted a lot of resources to smear us, including but not limited to:

1. Asked us (on other social media profiles, via phone, email or in person) to send them invitations to connect and then report us for unsolicited contact
2. Asked us (on other social media profiles, via phone, email or in person) to send them a message about volunteer opportunities and then report us for unsolicited contact

Based on independent legal advice, we have supplied the following robust hard evidence (attached to this cover letter) to confirm the ongoing sanctions against our multi award winning international support network needs to be immediately lifted as a matter of urgency:

Evidence number 1 – Detailed facts and information about us and our services for communities around the world

In particular, read the Home page and then read About Us, to understand we are well established.

After that, read the News page for proof all the issues we campaigned for were successfully won at the regulators or published by mainstream media. The articles withheld our name pursuant to the Victims Code, which permits evidence to be submitted anonymously.

We are on numerous social media platforms, which include *Twitter, LinkedIn, Tik Tok, Instagram, Facebook and You Tube*.

Evidence number 2 – Our identity known by millions of people around the world

Healed by Compassion is run entirely by volunteers who are victims, since we are all in ongoing legal battles with the perpetrators, the Victims Code allow us to remain anonymous. This is why individual volunteers are legally exempt from disclosing their identities. In line with other support networks of similar size, our group identity “Healed by Compassion” is known by millions around the world.

If you search our name “Healed by Compassion”, you will see we are at the top of internet search results.

Our largest social media platform is Twitter, where 40,150 people follow us and monthly impression often exceed millions.

We have been loyal customers of LinkedIn for many years and helped to boost LinkedIn’s global businesses at significant level.

We have a combined total of approximately 84,000 followers across all major social media platforms and have promoted **LinkedIn to millions of people around the world on incalculable and immeasurable occasions.**

Our IT Team regularly monitor and record evidence of our LinkedIn account.

We have attached the following 6 pieces of documentary evidence behind this letter.

Page 8 is a screen shot of our LinkedIn account a day before the sanction was applied, it shows we had 25,837 followers.

Page 9 is a screen shot of our LinkedIn account on 12 June 2022, it shows we earned 41,368 impressions in 1 weeks, which marked our profile in the top 5% of LinkedIn.

Page 10 is a screen shot of our LinkedIn content performance on 16 June 2022, it shows

we earned 617,778 impressions in 1 year.

Page 11 is a screen shot of the top companies where our searchers work on 27 July 2022, it shows professionals at NHS, MIT, Harvard University, Council of the European Union and the United Nations regularly view our award winning profile. In fact, many of our followers on social media are from these and other world renowned organisations.

Page 12 is a screen shot of our LinkedIn log in page on 29 July 2022, it made an unsubstantiated and unfounded allegation. Our lawyers advised the onus and burden of proof is on the accuser, since you are making the accusations, you must have valid evidence. In this case, there were no evidence from you.

Page 13 is a screen shot of our LinkedIn log in page on 6 August 2022, the reason for denying access was changed to “potential unauthorised access”, which is not true since the volunteer team remained the same and as a result there was never any kind of “potential unauthorised access”

Lawyers advised we show you the office email addresses of all the editors and senior journalists we regularly send evidence to. The information for all 195 countries is too much, so we attached the section for UK for you to see.

If the sanctions are not lifted as a matter of urgency, then it leaves us no choice but to escalate the distressing matter to all the TV stations and newspapers around the world, who will use broadcast and publish the issue, which affects billions of social media users.

Many of our volunteers are retired lawyers and with their help, we have established good working relationships with **law firms** in 195 countries around the world.

When you visit the top of the News page on our website, you will see proof about a landmark ruling, which the lawyers helped to win.

Lawyers advised we show you the office email addresses of all the senior lawyers we regularly refer the victims to. The information for all 195 countries is too much, so we attached the section for UK for you to see.

If the sanctions are not lifted as a matter of urgency, then it leaves us no choice but to escalate the distressing matter to all the law firms, who will use crowd funding and no win no fee to fund the lawsuits.

Evidence number 6 – Why individual volunteers are exempt from disclosing their ID

Healed by Compassion is run entirely by volunteers who are victims, since we are all in ongoing legal battles with the perpetrators, the Victims Code allow us to remain anonymous. This is why individual volunteers are legally exempt from disclosing their identities. In line with other support networks of similar size, our group identity "Healed by Compassion" is known by millions around the world.

Our lawyers advised we send you a summary of the complex legal battles one of our volunteers (who is also a victim) is going through, so you understand the need to remain anonymous.

Evidence number 7 – Urgent Judicial Review

Of the 26,000 people who follow our LinkedIn profile, thousands rely on the self-care advice and inspirations we regularly publish.

One day before the sanction, we published advice on healthy food and healthy lifestyle.

Since we were denied access to our LinkedIn account on 29 July 2022 and when our profile was made inactive, hundreds of victims contacted us on other social media sites and via phone, emails and letter to express their shock and to explain the impact on them.

The UK is currently going through "cost of living crisis", high inflation and soaring energy

bills, thousands of victims rely on the self-care advice and inspirations we regularly publish.

The lawyers advise if the wrong sanctions are not lifted as your earliest convenience, then it will leave us no choice but to take a set of legal actions, which include an Urgent Judicial Review in the High Court.

2. This letter is a complaint and not “pre-action”, which means it is too early to get your in-house legal team involved, albeit you may wish to seek their views.

3. As this support network is run entirely by volunteers who are also victims (understandably all of whom have already suffered enough injustice to last a lifetime), please ensure your reply is short, polite, not threatening and helps to heal the emotional

wound created by the wrong sanctions (e.g. apology, promise it will never happen again and assign a Senior Manager whom we can contact if a similar mistake re-occurs in future)

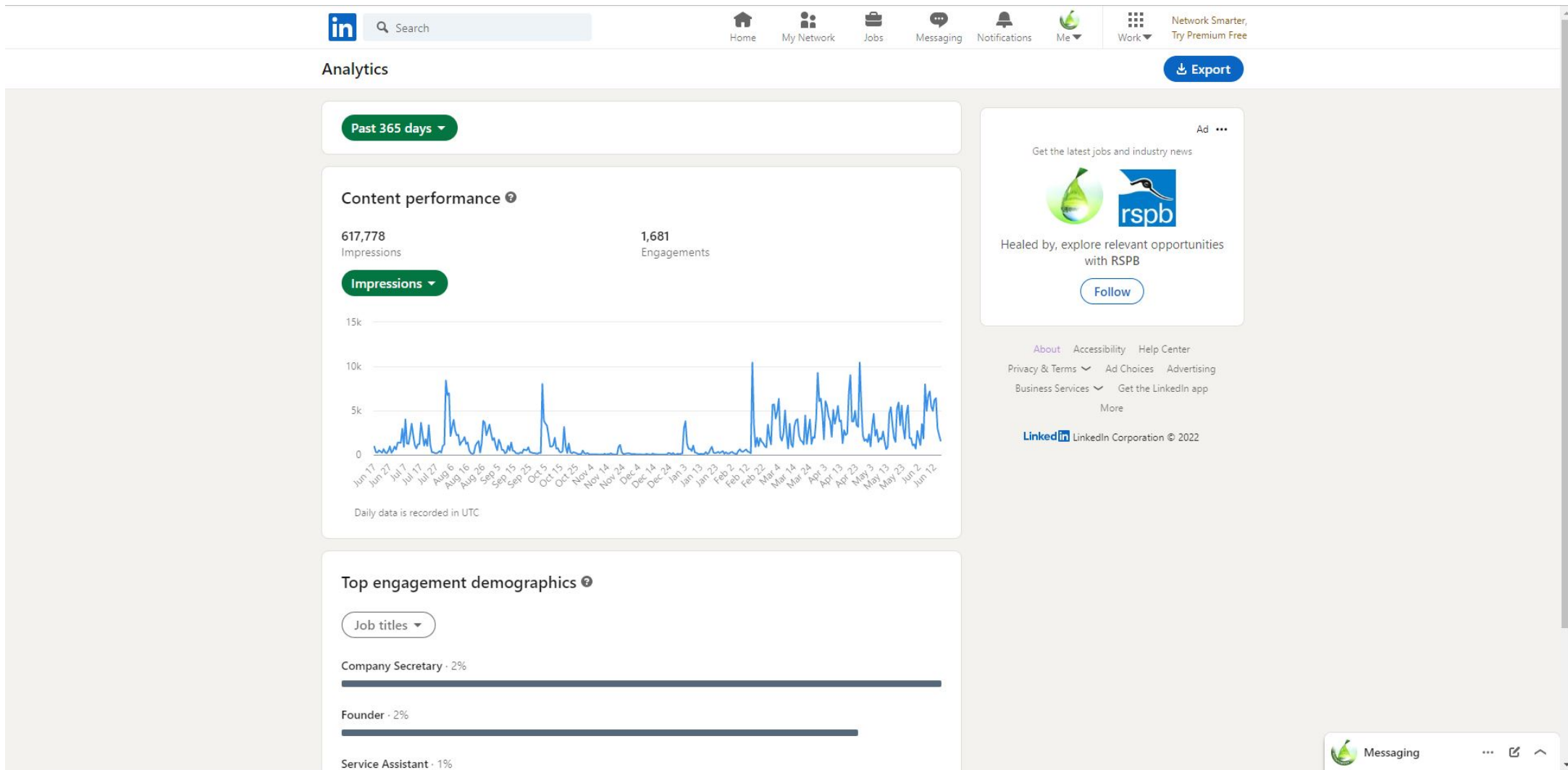

Legal actions suggested by lawyers:

The victim's family and supporters, based on legal advice, plans to sue individuals as well as organisations.

For the above mentioned reasons, facts and evidence, combined with threats to the victim's health, well-being and human rights, an Urgent or an Emergency Judicial Review will be appropriate if you refuse to rectify the situation and continue to cause distress and alarm (breach of Safeguarding).

What to sue and when:

Emergency Judicial Review

The health professionals who treat the severely disabled victim with life threatening chronic medical conditions are concerned about the impact of what you are doing on a defenceless and helpless individual. On this basis, an Emergency Judicial Review is necessary to stop the objectionable behaviour and actions. In Emergency Judicial Reviews, there is no need to serve pre-action (since it's an emergency).

Private Prosecution begins in Magistrates Court, since ██████ became a London Magistrate in 2017 and due to the fact he is well respected among judiciary in London region, the Private Prosecution will be commence in a Magistrates Court outside London (location to be decided in due course).

Private Prosecution has no time limit.

Public Inquiry

Since the victim's friends have combined 214,951 followers on social media, they can persuade the authorities to set up a Public Inquiry.

Statutory Investigations and Inquiries

Doctors and lawyers helping the victim, who is severely disabled victim with life threatening chronic medical conditions, informed his family that if the bullying, harassment, discrimination and victimisation harmed the victim's health to the extend of leading or contributing to his early death, then in addition to the statutory inquest, a Murder Inquiry will be launched.

The victim became an Expert at the International Criminal Court in 2019, his colleagues advised the International Criminal Court is very concerned with what is happening in the UK and communities supporting the victim will ask the International Criminal Court to open an inquiry.

Therefore please send a message to the email address we registered with LinkedIn in order for us to reply.

However, the pro bono lawyers helping us advised since the 42-page letter contain evidence only the account owner knows or possess, it is irrelevant which email address the letter is sent from. For the avoidance of doubt, "compassion@dr.com"

is our professional email address, albeit it is not the email address registered at LinkedIn.

Group ID has already been verified:

The Executive Escalation Case Manager also asked us to verify our ID, this matter has been fully addressed by pro bono lawyers in the 42-page letter addressed to the Chairman and Chief Executive of LinkedIn and its owner Microsoft, we have attached a copy for you.

In short, our identity is "Healed by Compassion", as evidenced in the 42-page letter and which you can verify online if you search "Healed by Compassion", you can view our official website and profiles on major social media platforms such as Twitter, where we have 40,300 followers.

As a matter of fact, we had communication with LinkedIn from our profile on Twitter about this matter, such communication count as verification of ID. LinkedIn Team on Twitter replied our direct message (which can only be seen by us and LinkedIn) and provided a web link for us to email the signed letter. We did and received a reference number, which is **Case: 220822-019617**

Individual ID is exempt:

As we are support network, and in line with protocol, we are exempt from disclosing individuals' names as we work together as a team. This is the norm for support networks around the world. In particular, the law requires the burden of proof is on the accuser, it is the accusers who must reveal or verify their ID. Further, pursuant to Victims' Code, individuals are exempt from disclosing their names since all our volunteers are victims and currently in legal battles against the perpetrators.

Second and third emails from you on 24 and 30 August:

In the subsequent 2 emails, you asked why we have not replied. As explained in the 42-page signed letter, we are an unfunded support network run by volunteers and all volunteers are extremely busy with their careers, families, commitments, lawsuits against the perpetrators (volunteers are also victims) in addition to running this award winning support network.

Further, we rely on pro bono lawyers for support, advice and expert opinion, which take weeks or even months. Therefore please don't set deadlines in your replies as it is not possible for us to meet those tight deadline due to our circumstances.

Reasonable requests:

1. The carefully written 42-page letter, which was typed on our official headed-paper and signed, contain all the robust hard evidence to prove there was no letigimate reason to deny access since 29 July 2022. As the journalists and lawyers helpfully pointed out, the restriction was marked as "temporary", which means it should be maximim of 1 week. In this case, it has been nearly 6 weeks, which is excessive and disproportionate. Therefore, please immediately send a link to the email address we registered with LinkedIn and grant access without further unnecessary delay.

2. As the international communities, our huge number of followers on other social media platforms, journalists and lawyers noticed, we have a long established good working relationship with LinkedIn and our 26,000 followers on LinkedIn are connected with millions of professionals around the world. Based on the long list of facts provided in our 42-page letter (a copy is attached), we have made significant contributions to the growth of LinkedIn around the world in the last decade and this cannot be overlooked or ignored. Therefore, please immediately send a link to the email address we registered with LinkedIn and grant access without further unnecessary delay.

3. If the above mentioned 2 reasonable requests are denied, we respectfully ask the Chairman and Chief Executive of LinkedIn and its owner Microsoftto either assign a different Executive Escalation Case Manager or assign their line manager to look into this matter. This is because the 42-page signed letter containing hard robust evidence, prepared by lawyers and journalists, is more than sufficient for you to restore access but instead you erected more hurdles and obstacles, which is unnecessary since this support network is run by volunteers and all of whom are victims in distress due to injustices they received from the world. Since 29 July, LinkedIn made a mistake by denying us access to our LinkedIn profile, which caused distress for a significant proportion of our 26,000 followers on LinkedIn.

Between 29 July and 22 August, communities in 195 countries, together with lawyers and journalists, prepared a 42-page letter (containing robust hard evidence) proving the restriction was a mistake.

The above mentioned letter was emailed to the Chairman and Chief Executive of LinkedIn and its owner Microsoft on 22 August.

Between 22 August and 5 September, 3 cases were opened (see below for reference numbers) but staff failed to properly read the evidence in the 42-page letter and as a result did not restore access.
