

To the UN Special Rapporteur on the Rights of Persons with Disabilities

29 April 2023

Dear Professor Quinn,

We are writing to you in your capacity as the UN Special Rapporteur on the Rights of Persons with Disabilities

Background:

A disability expert in the United Kingdom (a severely disabled person who had been Judge, Governor of 20 Hospitals, Governor of 5 Schools and Chairman of 3 Voluntary Organisations, and who graduated from 4 Universities) suffered 36 years of disability abuse and with help from experts in numerous voluntary organisations (including doctors, lawyers and judges), spent 1 year preparing a 500-page bundle of evidence. This was posted to the UN Committee on Rights of Persons with Disabilities in Switzerland by express air mail.

How the UN Committee treated the victim:

On the same day they received the 500-page bundle, they quickly sent an abrupt email to the victim to falsely accuse him of:

- (1) Not clearly explaining disability abuse**
- (2) Not meeting criteria for submission**
- (3) Not exhausting avenues in the UK**

All 3 accusations are totally unfounded, insulting and not supported by any evidence.

It is clear they never bothered to read the 500-page bundle because their short and abrupt rejection failed to provide analyses of any of the evidence submitted.

The evidence comes from the fact they emailed the rejection on the same day they received the 500-page bundle by air mail.

Experts advised it would take professionals at least 10 days to read and analyse the 500-page bundle and then another 30 days reading all the evidence in the password-protected website, for which a link was provided in the bundle.

Public response:

The aforementioned disability expert in the United Kingdom (a severely disabled who had been Judge, Governor of 20 Hospitals, Governor of 5 Schools and Chairman of 3

Voluntary Organisations, and who graduated from 4 Universities) suffered 36 years of disability abuse and with help from experts in numerous voluntary organisations (including doctors, lawyers and judges) showed the rejection email to thousands of people he helped in the last 36 years.

Experts and organisations around the world pointed out the UN and its Disability Committee are just as corrupt as the UK Government as proven in an award winning movie entitled The Whistleblower, which you can watch on Amazon Prime TV.

Whilst the UN Disability Committee did issue injunctions against the UK Government in the case of Archie Battersbee last year, but it ignored 99.9% of the 7 million disabled people in the UK who suffer disability abuse or discrimination daily basis, like the victim in this high profile case. The UK Government ignored the injunctions from the UN Disability Committee and went ahead with switching off the disabled victim's life support machine, which shows the UN Disability Committee has no real power and can be easily ignored. Therefore it was bewildering why the UN Disability Committee behaved in such heavy handed, arrogant and condescending manner towards a severely disabled who had been Judge, Governor of 20 Hospitals, Governor of 5 Schools and Chairman of 3 Voluntary Organisations, and who graduated from 4 Universities.

Remedy:

We would like you to appoint a panel of experts to review the 500-page bundle of evidence and the thousands of pages of evidence on the password-protected website.

Then we will provide you with the relevant details of the victim for the UN to trace the case, re-open it and properly investigate.
