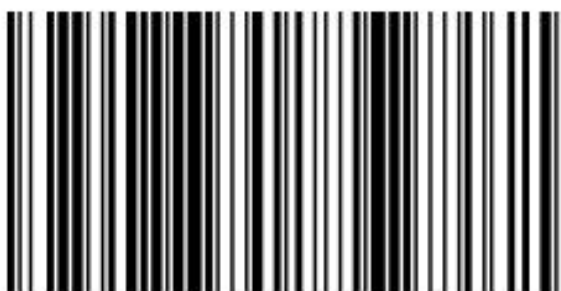

Purpose of this communication is two-fold:

1. To present you with 2 thank you poems
2. To ask you assign a senior manager to resolve an issue of wide public significance

Introduction:

Our health support network was established in 2010 and our prominent profile on X has existed since 2012 when the social media site was called Twitter. We are subscribed to Premium Blue membership via Apple i phone. Our X profile was a paid subscriber of Mr Musk's X profile, but cuts in funding prevented us from renewing.

1. To present you with 2 thank you poems

Our family members, relatives, friends, colleagues and neighbours, who are your loyal supporters and fan, asked us to present you with the following 2 thank you poems for all the wonderful work you and your colleagues are doing.

Thank you poem 1

Thank you for all you do for the communities;
You make life better for people around you;
Your continual acts of kindness brighten each day;
What you do for people will glow in their memories.

Thank you poem 2

Kindnesses always mean so much;
Kindnesses often grow far beyond their original intent;
And blossom with deep appreciation;
Thank you for everything.

2. To ask you assign a senior manager to resolve an issue of wide public significance

The issue of wide public significance in 4 succinct points:

(a) Our health support network is a part of a small health charity based in England. Since our annual income is less than £5,000, the British Government's tax authority HMRC granted us exempt status for all matters relating to tax. This means we do not need to answer questions about tax or fill in any tax forms. Our HMRC charity reference number is EW33811

(b) Recently our verified premium profile (with blue checkmark) on X earned over 8 million impressions in the last 3 months (which exceeded the threshold of 5 million impressions set by X) following excellent work by our dedicated team of volunteers, which means we are eligible to have a share of X's ads revenue promised by Mr Musk. As our mission has always been supporting socially disadvantaged communities, all our unpaid voluntary works are entirely for public benefit and there's absolutely no personal gains for any our of volunteers.

(c) However, X refused to transfer the money to our charity bank account because we did not have an Express Stripe account, even though we do have a Stripe account (but not the Express version). This is because every time we tried to sign up for Express Stripe on the web or on Apple i phone, the W-8/W-9 Certification section refused to recognise our legal status as a small charity in England who is exempt from all tax matters. The online automatic pop up messages then insisted we must submit another form called W-8 BEN-E Form, but every time X asked Stripe to send it to us, the links in the automatic emails took us back to the original application. This stressful and unnecessary process was repeated at least a dozen times, which exhausted all our volunteers and experts. Customer service and support teams at all levels in both X and Stripe could not successful resolve the issue.

(d)

- Friends who are journalists connected with us advised this issue is of widest public significance as both Governments in US and UK fully recognise and support small charities who do not need to deal with tax matters due to low level of incomes. Therefore, the issue affects all small charities and not just ours, which is why national and local media outlets agreed to publish if the issue is not resolved as a matter of urgency.

- Friends and relatives who are lawyers guided us to write formal letters and supplied hard evidence to X and Stripe, but so far the issue remain unresolved.

- The charity experts supporting us pointed out this issue is having significant impact on the communities we support.

Remedies:

1. Please assign a senior manager to urgently correct the identified flaws in the system so that all small charities like ours can receive payment for ads revenue generated by millions of impressions pursuant to the policies Mr Musk announced. Alternatively, please offer alternative ways to pay small charities, such as via Apple (if their premium membership was paid via Apple i phone like we did), bank transfer, cheque or payment link

2. For the money owed to us, please swiftly ask a senior manager to transfer the funds using one of the following methods:

(a). Please ask staff to urgently amend the Express Stripe online form or other appropriate actions to enable X to pay us for the ads revenue generated by approximately 8 million impressions we earned in the last 3 months.

(b). Pay us via the Stripe payment link (the green button) published in the Support Us section of our website (the address of our website is printed on previous pages of this letter). You can search the internet for our website, search Healed by Compassion on Google and our website is at the top of search results page one.

(c). Pay us by credit the money to our credit card (Apple has the details, and since our verified premium profile on X was paid via Apple i phone, you can pay us via Apple)

(d). Pay us via bank transfer, please email us at the email address printed below under the communication sub-heading and we will reply with our charity bank details

Closure:

Friends, relatives and supportes who are lawyers and journalists helping this distressing case of wide public significance trust you and your colleagues will quickly resolve the issue amicably and bring closure to the aforementioned ongoing issues. Thank you.
